Issuer's decision on planned merger with subsidiaries

#### Report contents:

BEST S.A. (the 'Company' or 'BEST'), in connection with the decision to merge BEST with FINSANO S.A. (a direct 100% subsidiary of BEST) and Kredyt Inkaso IT Solutions sp. z o.o. (an indirect 100% subsidiary of BEST — through FINSANO S.A.), announces that the above-mentioned companies today agreed and signed a merger plan drawn up according to Article 499 of the Commercial Companies Code (the 'Merger Plan') and each prepared a management report according to Article 501 of the Commercial Companies Code. These documents are attached to this report and will be available on the websites of the above-mentioned companies, i.e.: <a href="https://www.best.com.pl/">https://www.best.com.pl/</a>, <a href="finsano.pl/">finsano.pl/</a> and <a href="https://it.kredytinkaso.pl/">https://it.kredytinkaso.pl/</a>.

The Merger Plan provides for a merger under Article 492 § 1(1) of the Commercial Companies Code, i.e. a merger by acquisition of FINSANO S.A. and Kredyt Inkaso IT Solutions sp. z o.o. (the acquired companies) by BEST (the acquiring company), consisting in the transfer of all assets of FINSANO S.A. and Kredyt Inkaso IT Solutions sp. z o.o. to the Company without issuing any shares of the Company, without increasing its share capital and without amending the Company's Statute due to the prohibition on acquiring treasury shares resulting from Article 514 of the Commercial Companies Code.
