Early redemption of all K1 series bonds at the issuer's request

Legal basis:

Article 17(1) MAR – inside information

Report contents:

The Management Board of BEST S.A. (the '**Issuer**', the '**Company**') announces that on 10 September 2025 it adopted a resolution on the early redemption, at the Issuer's request, of all series K1 bonds issued by Kredyt Inkaso S.A. ('**Kredyt Inkaso**') prior to its merger with the Issuer.

Pursuant to item 13 of the Terms of Issue of Series K1 Bonds (the '**Bond Issue Terms**'), the Company will redeem 103,000 (one hundred and three thousand) series K1 bearer bonds with a current nominal value of PLN 666.68 (six hundred and sixty-six zlotys and sixty-eight groszy) each, with a total nominal value of PLN 68,668,040 (sixty-eight million six hundred and sixty-eight thousand and forty) issued by Kredyt Inkaso, whose legal successor is the Issuer, pursuant to Resolution No. X/1/03/2022 of the Management Board of Kredyt Inkaso of 24 March 2022 (the '**K1 Bonds**'). The K1 Bonds are registered with the National Depository for Securities (Krajowy Depozyt Papierów Wartościowych S.A.) under the ISIN PLO111400050.

All of the above-mentioned K1 Bonds will be redeemed.

Early redemption at the Issuer's request will take place on 28 September 2025 (Voluntary Early Redemption Date).

The early redemption of the K1 Bonds at the Issuer's request will be made according to the procedure described in the Bond Issue Terms.

The notice to Bondholders regarding the exercise of the early redemption option for the K1 Bonds at the Issuer's request will be posted on a webpage specified in the Bond Issue Terms.

Capitalised terms not defined above have the meanings ascribed to them in the Bond Issue Terms.
